Operation:

Synchronize the watch with your mobile device through the application:

 Download "HryFine" from APP Store (iOS) or Google Playstore (Android). Also available from the QR code shown below.

Functions:

Sleep Mode

This function can automatically detect and recognize your sleep pattern and monitors your entire sleep process based on the movements you make during the

You can set the start/stop time in the app and the result will display.

Measurements

This device allows you to measure the heartbeat and the blood pressure.

Press the main button until you get to the desired measurement screen. From the back of the smart watch, a green light beam will appear. Now you can start measuring.



The results displayed on the watch are synchronized automatically in the APP. Note: Automatic synchronization may take several minutes. Also you can start the measurement from the APP.

Notifications and Alarms

This device allows you to set different alarm types, such as message notify, call reminder and Application notify.

You can also set the alarm clock or sedentary reminder.

This device stores the last notification.

To see it, press the central button of the watch until you reach the last screen.

Note: You can turn off notifications in the DND mode (Do Not Disturb).





Exercise Mode:

This watch calculates steps, walking distance and calorie consumption. Press the main button until the following screen appears.



Note: Watch data will start from zero every day at 00:00h.

In addition, the device has the function "sports", which allows you to monitor sports activities such as running, jump rope or sit-ups. To do this, press the central button until you reach to corresponding screen and keep it pressed to access. Press the button to see the different options and keep it pressed again to access. At this moment, the timer will start. To finish, press and hold down the cental button.


To change the time format (12/24) of the main screen, long press the central button.

Camera Remote:

Open this function in the app on your mobile device and shake your watch to take a photo.

Turn off/Turn on your device:

Press the centre button until you reach the corresponding icons, then keep it pressed down.
